This Reference Product comes from a site that has received ISO14001 certification.



■ DISTRIBUTION ■

Products are distributed from logistics centres located with a view to optimize transport efficiency. The Reference Product is therefore transported over an average distance of 1405 km by road from our warehouse to the local point of distribution into the market Europe.

Packaging is compliant with European directive 2004/12/EU concerning packaging and packaging waste. At their end of life, its recyclability rate is 92 % (in % of packaging weight).

■ END OF LIFE

The product end-of-life factors are taken into account during the design phase. Dismantling and sorting of components or materials is made as easy as possible with a view to recycling or failing that, another form of reuse. This product falls within the scope of the WEEE directive (2012/19/EU). Therefore it must be processed through local WEEE recycling/recovery channels.

• Extended producer responsability:

The sale of this product is subject to a contribution to eco-organisations in each country responsible for managing end-of-life products in the field of application of the European Waste Electronic and Electrical Equipment Directive.

• Recyclability rate:

Calculated using the method described in technical report IEC/TR 62635, the recyclability rate of the product is estimated at 94 %. This value is based on data collected from a technological channel operating on an industrial basis. It does not pre-validate the effective use of this channel for the end of life of this product.

- for the products with antimicrobial finishes, the environmental impacts of each phase of the lifecycle are assimilated to the impacts of the Reference Product with an exception with the «Depletion of abiotic resources elements» indicator of the Manufacturing phase on which we have to apply an 1.35 coefficient on that of the Reference Product.
